- Aruba is 2hrs ahead. For instance: <u>8am</u> in Aruba (AST) is <u>6am</u> in Dallas (CST)
- To call the US from Aruba, dial 001 followed by 10 digit number
- Download free VOIP mobile apps to use to make free international calls and texts over WiFi connection. (i.e. Viber, Skype, Tango, Google Hangouts etc.
